1. **Correction to Final Instructions:** Some old wording slipped through the checking process ...
 - a. Replace “exclusion” by “disqualification” everywhere it occurs,
 - b. Replace “excluded” by “disqualified” everywhere it occurs,
 - c. Replace the two sentences about Co-driver licenses under the “Licences” heading with “Co-drivers require any Interclub, RS National, Race National, RS Rally National navigator, or any International Licence. If necessary, co-drivers may apply for an RS Interclub Licence at the event (H 25.1.4)”.
2. **Correction to Road Book:** page 4 – the length of stages 7 and 8 is 5.20 miles not 5.29 miles.
3. **Correction to Competitors’ Briefing:** the number of stages that must be completed to be classified as a finisher is 5 (as stated in the Regulations) not 6 (as wrongly stated in the Competitors’ Briefing).
4. **Driving Behaviour:** Driving Standards Observers/Judges of Fact have been appointed to observe driving standards on the road sections of the event. They will report to the Clerk of the Course any driving at excessive speed, or erratically, or in a manner likely to alarm spectators (this includes any “tyre-warming”). The following are appointed Driving Standards Observers and Judges of Fact for these purposes: Gavin Heseltine, Bernard Nolan, David Smith, Carl Thompson, Kirsty Thompson.
5. **Judges of Fact:** The following are named as Judges of Fact:
